**Speaker:** Chief District Attorney **Trish Mahre** will talk about her experiences being a woman in the legal field, about equal pay, and answer our questions.

Trish (Moran) Mahre grew up in Grand Junction, graduating from GJHS in 1984. She thereafter graduated from University of Colorado (B.S. Business, 1988) and from Seattle University School of Law (formerly University of Puget Sound) with a Juris Doctor degree in 1991. Her father was a long time oncologist, her mother worked in real estate, and she has three siblings in the medical and legal fields.

Trish worked as a prosecutor in Vancouver, WA, for many years prosecuting the full scope of crime, such as traffic, domestic violence, drugs, sexual assaults, burglary, and murder. She thereafter served as the municipal prosecutor for the City of Kelso (WA) during a transition to move back to Grand Junction. Since returning to Grand Junction, Trish has worked for the District Attorney's Office for the 21st Judicial District. She serves in the role of Chief Deputy District Attorney under District Attorney Dan Rubinstein. Trish is one of six female attorneys in the 22 prosecutor office. Her responsibilities include supervising the juvenile prosecution and diversion units, supervising the Victim Witness Unit, reviewing and charging incoming felony crimes, and prosecuting murder cases.

Trish has been married for 23 years to Chris Mahre, also an attorney, but in private practice. Together they have two children: Ryland (age 19, attending University of Utah) and Tommy (age 16, attending GJHS). Their interests include attending all their children's various activities, skiing, camping, yard work, and attending theater/performing arts.

# The Jane Quimby Book Group

The conclusion to April's book group discussion, about *All the Pretty Horses*, by Cormac McCarthy, was that it was not everyone's favorite book on this year's reading list. Uniquely styled without traditional punctuation, and smatterings of phrases and dialogue written in Spanish (sans translation), *All the Pretty Horses* was published in 1992. It won the National Book Award and paved the way for two more novels in the "Border Trilogy": *The Crossing* (1994) and *Cities of the Plain* (1998). McCarthy's writing style has been compared to that of Faulkner and Hemingway. Besides winning the Pulitzer Prize for Fiction, *The Road* (2007), McCarthy has won a Rockefeller Foundation grant, a Guggenheim fellowship and a MacArthur Foundation Grant. His personal life was as much of interest to our discussion as his writings. He was born "Charles", but changed his name to "Cormac", after an ancient Irish King; married 3 times; fathered 2 sons, made violence and the dreams of men with complex relationships and social protests all part of his stories, which often have been of questionable interest to the general reading public.



May's meeting, on <u>Friday, May 20</u>, beginning at 9:30 a.m. at American Lutheran Church, will feature the NY Times Bestseller, (made into a movie), "Still Alice", by Lisa Genova.

"A poignant portrait of Alzheimer's . . . Not a book you will forget." (USA Today) At once beautiful and terrifying, this story of early onset of Alzheimer's is a vivid and moving story.

Discussion will be led by Kaye Wergedal, and our welcoming hostess will be Marge Ebright.

### Interim Public Policy Report from AAUW Lobby Corps

Colorado AAUW took support or active support positions on several bills affecting <u>Women's Economic</u> <u>Security</u>. Currently one SB 16-022 (Sen. Martinez-Humenik, Rep. Pettersen) to extend to all counties the ability to participate in a pilot program to mitigate the cliff effect for low-income working families receiving child care assistance, has passed the legislature and is signed by the governor.

Several bills were killed in the Senate State Veterans and Military Affairs Committee:

SB 16-096 to re-create the Pay Equity Commission

- SB 16-114 to require employers to provide employee-earned paid sick time
- HB 16-1001 to require state contractors to comply with equal pay laws. This bill passed the House.
- HB 16-1002 to allow employee leave to attend a child's academic activities. This bill passed the House.
- HB 16-1166 to prohibit employers from asking salary history on job applications. This bill passed the House.

Other bills in this area that are still in process include:

- HB 16-1003 to restructure the college savings account program to benefit the middle class
- HB 16-1050 for a task force to address the child care needs of low-income parents of young children as they seek to advance their own education.
- HB 16-1156 for pay transparency to allow employees to share income information with each other.
- HB 16-1167 to reward and encourage businesses who follow fairness and pay equity principles for all their employees.

On issues of **<u>Reproductive Choice</u>**, AAUW opposed six anti-choice House bills, four of which died in committee, with the other two expected to have the same result. Two of the expected four Pro-Choice bills have been introduced. HB 16-1294 requires public and private insurers to cover all classes of contraception included in the Affordable Care Act. The bill has passed the House. HB 16-1322 to require contraception prescriptions to allow for purchase in 12-month

HB 16-1260 to **extend the statute of limitations for reporting sexual assault** from 10 years to 20 has passed the House.

On **Education Issues**, one of the two bills for funding full day Kindergarten for all has died and one is pending.
