Learn about the Food Bank of the Rockies



Olivia Van Gundy, the Food Bank's Community Engagement Coordinator, will conduct a tour of their new facility and a discussion of their programs. Olivia is a graduate of CMU in Mass Communications and has worked for the Food Bank since last September.

The region west of the Continental Divide in Colorado is served by the Food Bank of the RockiesWestern Slope Etkin Family Distribution Center. This allows the team based in Grand Junction, CO, to meet the specific needs of this large area efficiently and effectively. They partner with more than 140 Hunger Relief Partners in the region to distribute food and necessities to our neighbors struggling with hunger in 13 Western Colorado counties.

Also, we have noticed that the local VA has stepped up with many new programs for female veterans. Instead, we will try to collect funds for our AAUW WCCC Scholarship. While this scholarship is endowed (originally at \$10,000), the principal does not generate enough interest each year to allow for a significant award.

AAUW National in the News

On July 13, Rep. Cori Bush (D-MO-1) and Sen. Kristen Gillibrand (D-NY) introduced the ERA Now resolution (H.J. Res. 82), which would remove the ratification deadline and ask the Archivist to publish the ERA as the 28th Amendment. You can watch the [press conference for the ERA Now resolution here](#). AAUW strongly supports both H.J. Res. 25 and H.J. Res. 82.

On July 27, the Senate Appropriations Committee voted to increase funding for the Department of Education's Office of Federal Student Aid by \$150 million. (This includes increasing the maximum Pell grant award by \$250.) While the amount falls short of President Biden's budget request to increase funding by \$620 million, the increase in funding stands in stark contrast to the education cuts proposed in the House. Congress will continue to debate the appropriations bill in September.

In July, the White House took steps to provide debt relief to student loan borrowers by announcing plans to [enact a new debt relief program](#) under the Higher Education Act and discharge [\\$39 billion in student loans](#) for 804,000 Americans through fixes to income-driven repayment plans. AAUW joined more than 175 organizations in calling on President Biden to enact his new plan as swiftly as possible and deliver urgently needed relief to borrowers.

In observance of World Day Against Trafficking in Persons on July 30, AAUW CEO Gloria L. Blackwell hosted a virtual event with Dr. Laura Dean, Director of the Human Trafficking Lab at Millikin University and an AAUW American Fellowship alumna, on combatting global human trafficking. The National Governors Association has launched a new effort called "[Disagree Better](#)." The initiative's goal is to diffuse political polarization through public debates, service projects, and public service announcements. It aims to model a more positive and optimistic way of working through our political disagreement.
