WHAT YOU MISSED LAST MONTH

Actually, very few of you missed it because we had a very good turn-out for the Program Meeting on April 14 with Shenna Hayden, the Executive Director of the Museums of Western Colorado. The Museums of Western Colorado includes the *Museum of the West, Dinosaur Journey and Cross Orchards Historic Site*. Here are some highlights from the notes I took.

Before taking the job in Grand Junction not many months ago, she had accepted a position at a museum in Olympia, Washington in 2019 where she had been hired to grow that museum's endowments and size. But COVID came, and she switched to children and family programs, which she found she enjoyed.

Shenna said that museums are becoming more interactive, not just for children, but also for families. One example are field trips for K-12 students in Title 1 schools. Cost for a student is \$5, of which \$3 goes toward the bus: there is a fund for students unable to pay. The museums host educational programs and workshops: 4th grade students work on Colorado History with hands-on experiences with artifacts.

In 2024, the three museums had 52,780 visitors. The Museums of Western Colorado is one of only 116 accredited museums by the American Association of Museums (AAM). One of the criteria of Money Magazine's "Best Places to Live" is having an accredited museum. AAM says that overall, museums contribute \$50 Billion to the US Economy each year, and 726,000 jobs. Federal Government funding may be at risk in the future

Currently Shenna is working on new exhibits at Museum of the West, trying to preserve women's history. She wants people to know what women did around the home in various decades. She plans to change exhibits more often...using items from their large storage facility. She also wants to work on community engagement----inspiring change through cultural heritage. And she wants to try to set up projects for teens.

The Goals for the Museums of Western Colorado for 2027-2031 are:

- Set up partnerships within the Community
- Increase the diversity of revenue
- Have more educational experiences and programs
- Remove barriers to visitations....possible discounts for admission

AAUW CONDEMNS EXECUTIVE ORDER TO DISMANTLE THE U.S. DEPARTMENT OF EDUCATION

Action Jeopardizes Students' Futures; Congress Should Not Allow Further Cuts and Take Immediate Action to Protect Students

Washington, D.C. — The American Association of University Women (AAUW) unequivocally condemns President Trump's executive order "Improving Education Outcomes by Empowering Parents, States, and Communities" dismantling the U.S. Department of Education.

"This reckless and shortsighted action threatens to gut vital protections that ensure equal access to higher education and will have devastating consequences for students — especially women, students of color, and those from low-income backgrounds — who rely on federal oversight for their right to an equitable education," said Gloria L. Blackwell, CEO of AAUW. "Eliminating the Department of Education would decimate federal civil rights enforcement, slash protections against gender-based discrimination, and roll back decades of progress toward making higher education accessible and affordable. This decision is not about streamlining government; it is about stripping students of their rights and futures."

Consequences of this action may include:

- Low-income students may lose vital federal financial aid that makes it possible to earn their degrees;
- Survivors of sexual harassment and assault on campus may see more Title IX cases dismissed and drastically weakened pathways to justice;
- Students with disabilities could be left without critical safeguards to protect and enforce their rights in schools.
- LGBTQ+ students who experience harassment and discrimination could face unsafe environments without their schools being held accountable;
- Student loan borrowers may be more vulnerable to abuse by predatory for-profit colleges and noncompliant servicers while facing unaffordable repayments

AAUW urges Congress to speak out against this move and protect the Department from any further cuts that could hinder enforcement of federal civil rights laws protecting students and preserving access to higher education. The cost of inaction is too high, and the futures of millions of students — especially those from marginalized communities — hang in the balance. In response to these coordinated and continuing attacks on education in America, AAUW is launching The Defend Higher Education Fund to enable AAUW to elevate the critical higher education issues impacting women, mobilize advocates across the country, provide strategic resources to students, staff and faculty on campus, and fuel investments in the infrastructure and technology necessary to move our mission forward.
